Steven Schatz joins FedArb after a 50-year career as a highly sought-after litigator in securities litigation and general commercial disputes. He has navigated numerous successful outcomes in shareholder suits, financial fraud matters, partnership disputes and M&A cases.

During his nearly 40 years with Wilson Sonsini, he served as lead counsel in 175 class actions throughout the country and has participated substantially in more than 100 mediations across a wide variety of disputes. As an appellate lawyer, he has argued more than 30 times in various federal Courts of Appeal as well as the Supreme Courts of California and Delaware.

His representations have run the gamut from technology to biotech, from apparel to financial services to not-for-profit colleges and on-line learning to gaming. His individual representations have ranged from start-up entrepreneurs to individuals who held prominent positions in business and government. At Wilson Sonsini, he served as counsel in some of the most significant and sensitive matters including as Hewlett-Packard's lead trial counsel in Walter Hewlett's unsuccessful challenge to HP's acquisition of Compaq in Delaware Chancery Court. In SEC v. Siebel Systems, he represented the defendants in the first successful challenge to a suit by the SEC under Reg. FD and has been lead counsel in numerous merger cases including for Freescale Semiconductor, which at the time was the largest going-private transaction in the technology industry.

He has also arbitrated matters involving break-ups of well-known financial institutions, representations on behalf of departing partners, and even a dispute over the ownership of a commercial aircraft.

Steve has become known as someone "who knows how to settle cases," including securities and merger class actions to partnership disputes to post-merger price adjustment suits. He studies the facts and ferrets out the needs of each of the constituents-the plaintiffs, the defendants and (where applicable) the insurers. He seeks resolutions that are efficient, expeditious and fair.
